DECLARES

That following the Regulation (EU) 2023/607 of the European parliament and of the council of 15 March 2023 amending Regulation (EU) 2017/745 and (EU) 2017/746 as regards the transitional provisions for certain medical devices and in vitro diagnostic medical devices, an extension of the transition period has been approved under conditions until 31st December 2028 for medical devices that are not class III medical devices nor class IIb implantable medical devices.

We, RADIOLOGÍA, S.A. attest that we are in compliance with all the requirements mentioned on Regulation 2023/607 as follow:

- Our devices continue to comply with Medical Device Directive (MDD)
- There are no significant changes in design and intended purpose of our devices.
- The devices do not present an unacceptable risk to the health or safety of patients, users, or other persons, nor to other aspects of the protection of public health.
- RADIOLOGÍA, S.A. has a quality management system compliant with MDR (EU) 2017/745 article 10(9) before 26 May 2024
- RADIOLOGÍA, S.A. has lodged a formal application with a notified body before 26 May 2024
- RADIOLOGÍA, S.A. has already signed a contract covering devices for transition for the devices covered within the MDD certificate.

We, RADIOLOGÍA, S.A. also attest that our transition from MDD to MDR is in progress. All the procedures have been initiated to our notified body.

Consequently, the Medical Device Directive (MDD) 93/42/EEC certificate ES19/85995.01 issue 3 expiring on 19th July 2023 are still valid till the edition of Medical Device Regulation (MDR) certificate and no later than 31st December 2028 for the class IIb devices.

No new certificate will be issued by our notified body SGS Belgium NV (CE1639), just only Corrigendum of the mentioned certificate.

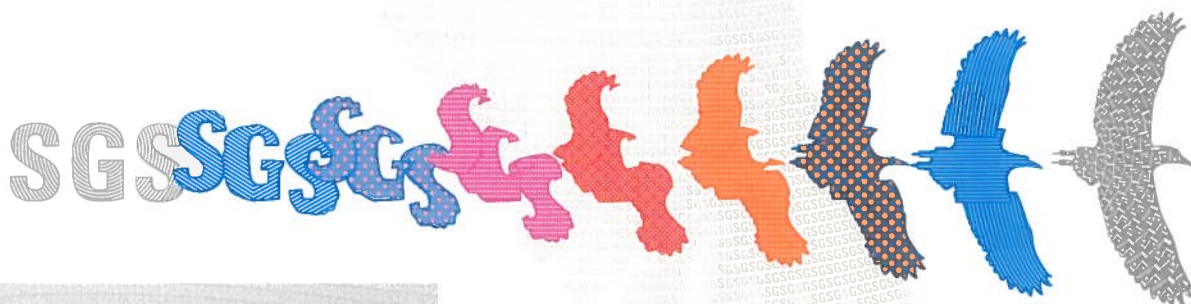
